Dear P.S. Q233 Families:

I am writing to share that the New York City Department of Education (NYCDOE) is proposing to open and co-locate a new middle school site of an existing District 75 school, P.S. Q233 (75Q233), to be called P233Q@Q210, serving students in grades 6-8 in building Q210 in the 2025-2026 school year. Q210 is located at 93-11 101 Avenue, Queens, NY, 11416 in Community School District 27.

As you know, P.S. Q233 is an existing multi-sited District 75 school currently serving students in grades K-12 across nine different locations in Queens. If this proposal is approved, P233Q@Q210 will open in Q210 where it will be co-located with J.H.S. 210 Elizabeth Blackwell (27Q210), referred to as Elizabeth Blackwell, an existing district middle school serving students in grades 6-8, in the 2025-2026 school year. A co-location means that two or more schools are located in the same building and may share common spaces, such as auditoriums, cafeterias, gymnasiums, and libraries.

If this proposal is approved, P233Q@Q210 would add approximately 48-96 District 75 special class seats in Q210 for District 75 students in grades 6-8 who have a classification of autism, intellectual disability, or multiple disabilities on their Individualized Education Program (IEP). Based on current and projected enrollment for Elizabeth Blackwell, Q210 has sufficient space to accommodate this co-location.

There is no expected impact on any of the P.S. Q233 sites that your child or children may currently attend.

In advance of the Panel for Educational Policy (PEP) vote, a Joint Public Hearing for this proposal will be held via teleconference on Wednesday, April 2, 2025, at 6 p.m. All community members will have the opportunity to share feedback about this proposal at the Joint Public Hearing.

This proposal must be voted on and approved by the PEP prior to implementation. We anticipate that the PEP will vote on this proposal on Wednesday, April 23, 2025, at 6 p.m. at Long Island City High School, located at 14-30 Broadway, Long Island City, NY 11106.
